

We are thrilled that you are interested in joining several America colleagues, and ourselves, on a special **10-day pilgrimage to Rome and Assisi from October 19 - 28, 2023.** It will be wonderful to walk in the footsteps of St. Francis and Pope Francis!

With the help of our friends, the professionals from Catholic Travel Centre, we have designed a pilgrimage to bring you to some of the most notable places of our faith. Together, we will visit La Verna (where St. Francis lived and preached), The Church of Santa Maria degli Angeli (known as the "Mother Church" of the Franciscan Order), St. Peter's Basilica, the Church of the Gesu (the Mother Church of the Jesuits), the Church of St. Ignatius Loyola, the Rooms of St. Ignatius and the Vatican Museum, among other key sacred spots.

Visiting historical sites, participating in Masses, and gathering for faith sharing will accompany times for personal reflection, prayer, and silence that connect us more deeply to our faith, St. Francis, St. Ignatius, and our heavenly Father.

Our Daily Itinerary

THURSDAY, OCTOBER 19, DAY 1: DEPART THE USA

Passengers depart under their own flight arrangements en route to Rome.

FRIDAY, OCTOBER 20, DAY 2: ARRIVE ROME / TRANSFER TO ASSISI

We will establish a meeting point at the Rome airport at 12:00 noon where we will all gather and board our waiting motor coach to transport us to the region of Umbria, home to the town of Assisi. After check-in at the Hotel Giotto, located inside the walls of the old town, we gather for a reception and orientation meeting followed by dinner at our hotel. (R, D)

SATURDAY, OCTOBER 21, DAY 3: ASSISI: BASILICA OF ST. FRANCIS & WALKING TOUR OF TOWN

After breakfast at our hotel, and a talk by Fr. Dan Horan, OFM, we celebrate Mass at the Basilica of St. Francis. After Mass we visit the Basilica, a UNESCO World Heritage Site. The Basilica has an upper and lower church. The churches have been decorated by the greatest late medieval Roman, Umbrian and Tuscan artists of their time, giving these churches an unequaled importance in the development of Italian art. The lower church has frescos by renowned late-medieval artists, such as Cimabue, and in the upper church, we see Giotto's magnificent frescoes.

After some time for lunch on our own, we begin a walking tour of the town which will highlight the major sites in the life of St. Francis including the Chiesa Nuova, built over the home of Francis' family. We'll be sure to include the Church of St. Mary Major where, some 800 years ago, St. Francis dramatically renounced his father's wealth, disrobing in the presence of his father and the bishop. And the Basilica of St. Clare, where St. Clare lies in repose. Here we see the original 'San Damiano' crucifix that spoke to Francis. We return to our hotel for Faith Sharing. Dinner tonight is on our own to explore the local restaurants. (B)



SUNDAY, OCTOBER 22, DAY 4: ASSISI: EXCURSION TO LA VERNA

After breakfast and a talk by Fr. Horan OFM, we depart Assisi for the secluded mountain retreat of La Verna. Here we visit the Sanctuary of San Francesco, a site of constant pilgrimage over the centuries and a religious center known all over the world. There Francis founded a small hermitage community and in 1224, two years before he died, Francis received from Christ the final seal of the stigmata. After St. Mary of the Angels, this place was Francis' favorite place for quiet meditation. Today the sanctuary stands as a beautiful and unique spiritual retreat. We celebrate Mass and visit Sasso Spicco, the great overhanging rock under which Francis delighted to pray, as well as the beautiful Chapel of the Birds. After a light lunch here in La Verna, we return to our hotel for Faith Sharing. We gather for dinner this evening. (B, L, D)

MONDAY, OCTOBER 23, DAY 5: ASSISI / SANTA MARIA DEGLI ANGELI / ROME

After breakfast and a talk by Fr. Horan OFM, we check-out of our hotel and board our motor coach. We stop at the village of Santa Maria degli Angeli, where we celebrate Mass at the Basilica of St. Mary of the Angels, containing the Porziuncola, rebuilt by St. Francis and his followers. The Porziuncola is a tiny church constructed within the Basilica, like a ship in a giant bottle. Nearby is the site of Francis' death.



After some time for lunch on our own in Santa Maria degli Angeli, we continue on to Rome. We check-in at the Le Méridien Visconti Hotel, conveniently located between the Vatican and Piazza del Popolo, in the heart of Rome. We gather for Faith Sharing, followed by a welcome reception at our hotel followed by dinner at a nearby local restaurant. (B, R, D)

TUESDAY, OCTOBER 24, DAY 6: ROME: GESU, ROOMS OF IGNATIUS & TOUR OF IGNATIAN SITES

After breakfast and a talk by Fr. James Martin, SJ, we visit and celebrate Mass at the Church of the Gesú (Church of the Holy Name of Jesus), the Mother Church of the Society of Jesus, where Ignatius is entombed. The church was built on the same spot as the previous Church *Santa Maria della Strada*, where Ignatius had once prayed before an image of the Blessed Virgin. Marking a transition between Renaissance and Baroque styles, the Gesú became a model for Jesuit churches around the world. Next, we visit the *Rooms of Ignatius.* The rooms represent the fifth and final residence of Ignatius in Rome. From his residence in the top floor of the building, Ignatius governed the worldwide Order, and from here he penned his more than 7,000 letters on a wide range of topics. Here as



well Ignatius drew his last breath on July 31, 1556. After a light lunch at a local restaurant, we enjoy a walking tour of Ignatian sites, including the Church of San Ignazio. Constructed in pure Baroque style, the Church was completed a halfcentury after the

Gesú. St. Aloysius Gonzaga and St. John Berchmans are both buried here. We see as well the Collegio Romano and the Collegio San Roberto Bellarmino, a house of studies for Jesuit priests and brothers preparing for advanced academic degrees. Our walking tour concludes at the Gregorian University. We return to our accommodations for Faith Sharing and dinner is on our own to explore the Roman cuisine. (B, L)



WEDNESDAY, OCTOBER 25, DAY 7: ROME: GENERAL PAPAL AUDIENCE & JESUIT CURIA, PLUS AFTER HOURS VATICAN MUSEUM TOUR

After breakfast and a talk by Fr. Martin SJ, we transfer to Vatican City for the General Audience with His Holiness Pope Francis (subject to the Holy Father's schedule). After the audience, we will walk to the nearby Jesuit Curia for Mass and a visit, followed by lunch. We return to our accommodations for Faith Sharing.

Early this evening we have requested a semi-private visit of the Vatican Museums and Sistine Chapel (subject to final confirmation). The restoration of the Sistine frescoes reveals startling bright colors—a new light on Michelangelo! The Sistine was commissioned by Pope Sixtus IV to mark the Holy Year 1475. Dinner is on our own. (B, L)

THURSDAY, OCTOBER 26, DAY 8: ROME: ST. PETER'S BASILICA & FREE TIME

After an early breakfast and a talk by Fr. Martin SJ, we celebrate Mass at the Basilica of St. Peter. We will also have time to pray at the tomb of Saint John Paul II and of Saint John XXIII. After Mass, our guide will show us the Basilica. With Michelangelo's dome, the Basilica is the most prominent building inside Vatican City. Built over the site of "Old Saint Peter's" constructed by the Emperor Constantine in the fourth century, the new Basilica began construction in 1506. The building absorbed the attention of twenty popes and ten architects before completion in 1626. There are over 100 tombs located within the Basilica. These



include 91 popes. Here we see the Papal Altar covered with the sumptuous bronze baldachin by Bernini, and the apse, aglow with golden mosaic. In addition to many sculptures and monuments by Bernini and other great artists, we will see Michelangelo's famous statue of The *Pietà*. Lunch is on our own.

The balance of the afternoon is at leisure. We gather at our accommodations for Faith Sharing. Dinner this evening is on our own to explore the local restaurants. (B)

FRIDAY, OCTOBER 27, DAY 9: ROME: BASILICA OF ST. MARY MAJOR & BASILICA OF ST. PAUL'S OUTSIDE THE WALLS

After breakfast and a talk by Fr. Martin SJ, we visit the Basilica of St. Mary Major, in whose Chapel of the Manger Ignatius offered his first Mass one year after the date of his ordination. Ignatius had wanted to celebrate his first Mass in the Holy Land, but he was unable to do so. The chapel in Rome was reputed to contain relics of the original manger from Jesus' time, so Ignatius thought this to be a suitable substitute location.



After a light included lunch, we celebrate the final Mass of our pilgrimage at the Basilica of St. Paul's Outside the Walls, housing the Tomb of St. Paul the Apostle, affectionately known as the Apostle of the Gentiles. Here Ignatius and five companions made their solemn vows on April 22, 1541. Although heavily restored, the present basilica looks much the same as it did in the 4th century. We return to our accommodations for some time at leisure. After Faith Sharing in as meeting room we enjoy a farewell dinner at a local restaurant. (B, L, FD)

SATURDAY, OCTOBER 28, DAY 10: END OF OUR JOURNEY TOGETHER

After breakfast, pilgrims transfer to the Rome airport on their own. The hotel concierge will be happy to assist you if you need to arrange a private transfer to the Rome airport. (B)

Note: While no changes are anticipated, there may be unforeseen occasions when certain alterations become necessary to this itinerary, either due to changes in airline schedules or for other reasons. All Masses are subject to local church schedules.

HOW TO REGISTER

Registrations are processed in the order received and many groups fill up quickly, so please register soon. Deadline for initial registration is **March 31, 2023**. To attempt to register after this date, inquire first to learn if any space is still available. Online registration is not available at this time.

To make your reservation, complete the Registration Form included in this PDF document and submit your \$2,000 per person deposit, mailed to the address shown on the bottom of the Registration Form. CTC will send your invoice via postal mail within two weeks of our receipt of your deposit. Final payment is due 120 days prior to departure, by **June 20, 2023.**

LAND ONLY TRAVEL PACKAGE

All passengers will make their own airline arrangements and connect with the group in Rome. We will establish a meeting point to be advised at the Rome Airport at 12:00 noon on Friday, October 20, 2023 to board our motor coach to Assisi. Travelers are also welcome to make their own transfer arrangements to Assisi and meet up with the group at our Assisi hotel.

TERMS AND CONDITIONS

ACCEPTANCE OF TERMS & CONDITIONS: Any payments made by a Traveler or on behalf of the Traveler ("Traveler", "you") to Catholic Travel Centre (CTC) toward any CTC tour shall constitute acceptance of all Terms & Conditions provided herein.

PAYMENT TERMS: All payments shall be made on the dates indicated in the payment schedule, noted in the Registration Information section. Late payments are subject to a non-refundable \$150 fee, and may result in cancellation. A Traveler registering with in 120 days prior to departure must provide full payment by cashier check, plus a non-refundable late registration \$150 fee. CTC reserves the right to cancel registrations not paid in full 105 days prior to tour departure and to charge fees per the Cancellation Policy. A non-refundable \$75 fee is charged on all returned payments. Travelers agree not to dispute any credit card charges associated with this trip before contacting CTC first to resolve their concerns. CTC retains the right to dispute any chargeback that is improper and recover any costs, including attorney's fees related to improper chargebacks. Additionally, in the event of an improper chargeback NOTE: Credit card charges will not show as "travel expense" on your credit card statement, but will appear as "specialty services", "shopping" or another designation.

CHANGES IN FORM OF PAYMENT: To change from Cash Discount to Standard pricing, the difference between prices plus an additional \$75 fee applies. After a Traveler's credit card has been charged for any portion of the tour, s/he is ineligible for the Cash Discount Price.

PARTIAL PACKAGES NOT AVAILABLE: Tour Packages are offered as described in this brochure, at the stated price. Partial package purchase is not available.

CANCELLATION POLICY: CTC's cancellation policy is in effect upon first payment toward any CTC tour. A Traveler's cancellation must be provided in writing either by email, fax, or registered mail to CTC. The cancellation is effective on the date of the cancellation email, fax, or date of postmark. The Traveler forfeits the following fees to CTC based on the date of cancellation notice: anytime up to 150 days prior to departure, \$500 fee; 149 to 120 days prior to departure, \$1,000 fee; 119 to 90 days prior to departure, \$1,500 fee; 89 to 75 days prior to departure, \$2,000 fee; 74 to 60 days prior to departure, \$3,000 fee; 59 to 30 days prior to departure, \$4,000 fee; 29 days or less, all payments by Traveler made to CTC are forfeited, and there are no refunds. In event of individual cancellation, no name changes or substitutions are permitted. No shows: Passengers who do not show up for the group's departing flight (or land only passengers who do not show for first hotel night) will be considered as tour cancellations: their airline and/or hotel reservations will automatically be cancelled and cannot be reinstated.

PRICES: If the group does not reach the size quoted, the price or programming will be adjusted accordingly. Pricing is based on exchange rates and fares applicable at the time of quotation and is subject to change.

PASSPORT: A valid passport is required of all U.S. citizen passengers. Travelers of other nationalities should inquire with the appropriate embassies, and such Travelers are responsible for securing their own visas if required in addition to their valid passport. Travelers' passports must be valid for six (6) months following the return date of the trip. CTC expressly denies any responsibility for any losses incurred due to insufficient validity of a Traveler's passport.

HEALTH & MEDICAL CONSIDERATIONS: The Traveler is responsible for identifying and securing any health/medical related documentation required by the airlines and/or countries visited on the itinerary, and CTC bears no responsibility for the passenger not providing the required documentation. If a country requires proof of COVID vaccination and/or a negative COVID test, it is the responsibility of the passenger to secure such documentation within the required timeframe as a condition for joining this tour.

Our suppliers (hotels, airlines, motor coach companies, etcetera) have agreed to abide by COVID-protective measures as outlined by local health authorities and government agencies, and the traveler agrees to abide by these policies as well. The Traveler understands that while CTC has made a reasonable inquiry to ensure these policies are adhered to by our suppliers, there may be occasions when the policies are not followed as completely as the policy suggests. Therefore, the Traveler agrees not to hold CTC, our suppliers, or the group leaders responsible should they contract any illness during or after their travel. It is highly recommended Travelers be medically healthy and physically capable of significant walking. Should you choose to travel to a country that has been issued a travel warning or advisory, CTC will not be liable for damages or losses that result from travel to such destinations. CTC cannot change its Cancellation Policy or Terms & Conditions based on any such warning or advisory or the occurrence of any terror, health, pandemic, or other incident in one or more of the places this tour is scheduled to visit. All cancellation penalties remain in full force and effect. It is your responsibility to be aware of any and all requirements for admittance to a country or state, including COVID-19 requirements. Certain countries have a requirement for foreign visitors to have valid medical insurance on entry. CTC cannot be held responsible for denied entry if the Traveler is unable to provide details to authorities of insurance or denial of entry for any reason.

ITINERARY: The itinerary presented in this brochure represents what CTC is planning for this trip; however, the itinerary is subject to final confirmations and changes in local schedules. While no changes are anticipated, CTC, at its sole discretion, reserves the right to change the itinerary, as it deems necessary or advisable. CTC is not responsible for costs or fees related to itinerary changes necessitated by changes in an airline's schedule or other arrangements not made through CTC.

TRAVEL DOCUMENTS: Travelers will receive their final travel documents approximately two weeks prior to departure.

ACCOMMODATIONS AND MEALS: Accommodations are based on double/ twin rooms with private bathroom facilities. A limited number of single rooms are available and are subject to a single room supplement fee. If no roommate is available for you, or your roommate cancels prior to departure, a single room supplement surcharge applies. Triple rooms are not always available and are discouraged because of cramped quarters; no price reduction for triple rooms. Meals are either menu of the day or buffet. Included meals are as shown in the itinerary (B=Breakfast, L=Lunch, D=Dinner, R=Reception).

LAND ONLY PASSENGERS: Travelers arranging their own airline ticket must meet the group at the first hotel of the itinerary.

BAGGAGE & PORTERAGE: Baggage is at Traveler's risk. Traveler should confirm the checked and carry-on baggage specifications with the air carrier specified in Final Travel Documents. Any checked baggage fees, if applicable, are not included in the tour price. Checked baggage is limited to one bag per person (subject to change by airline) and must adhere to airline specifications. Porterage for one piece of luggage is included at hotels; no porterage at airports.

NOT INCLUDED IN THE PRICE: Passports, visas, meals and beverages not mentioned, extras beyond standard menu, baggage fees, telephone calls, laundry, medical tests, and other items not explicitly stated as included.
